The MMAA has two different classifications for membership:

#### Registered Member:

A Clerk, Treasurer, Secretary-Treasurer, CAO, Resident Administrator of a Municipality, LGD or a quasi-municipal body or any person otherwise qualified as an Associate member who has obtained their Certificate in Manitoba Municipal Administration;

#### Associate Member

Does not qualify as a Registered Member, but is an employee of a Municipality, LGD or a quasi-municipal body and performs functions of an administrative or clerical nature or is enrolled in the Certificate course in Manitoba Municipal Administration or is a member of the staff of the Government of Manitoba and is engaged in duties related directly to the CAO, Treasurer or Administrative functions (i.e., Municipal Service Officer);

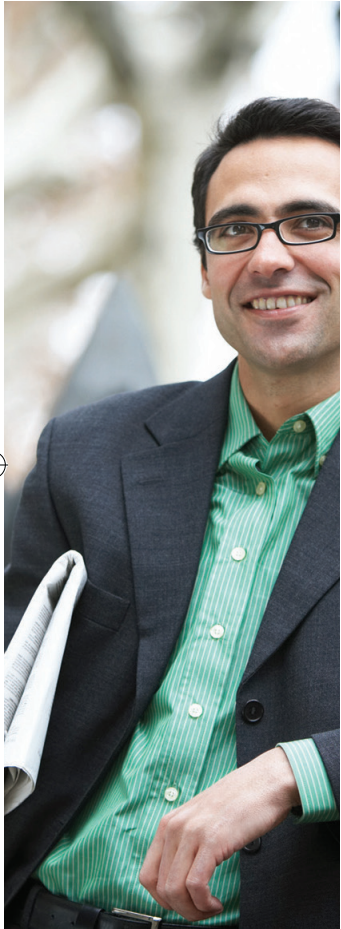
